### SECTION 4: First aid measures

#### Description of first aid measures

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on their side in the recovery position and ensure breathing can take place.
<b>Ingestion</b>	Rinse mouth thoroughly with water. Do not induce vomiting unless under the direction of medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Place unconscious person on their side in the recovery position and ensure breathing can take place. Maintain an open airway. Loosen tight clothing such as collar, tie or belt.
<b>Skin Contact</b>	Remove contaminated clothing immediately and wash skin with soap and water. Continue to rinse for at least 15 minutes. Get medical attention if symptoms are severe or persist after washing.
<b>Eye contact</b>	Remove any contact lenses and open eyelids wide apart. Continue to rinse for at least 15 minutes. Get medical attention if symptoms are severe or persist after washing.

**Protection of first aiders** First aid personnel should wear appropriate protective equipment during any rescue. Wash contaminated clothing thoroughly with water before removing it from the affected person, or wear gloves. It may be dangerous for first aid personnel to carry out mouth-to-mouth resuscitation.

### Most important symptoms and effects, both acute and delayed

**General information** The severity of the symptoms described will vary dependent on the concentration and the length of exposure.

**Inhalation** Irritation of nose, throat and airway. Prolonged inhalation of high concentrations may damage respiratory system.

**Ingestion** May cause stomach pain or vomiting. Fumes from the stomach contents may be inhaled, resulting in the same symptoms as inhalation.

**Skin contact** Prolonged and frequent contact may cause redness and irritation.

**Eye contact** Irritating to eyes. Redness.

## SECTION 5: Firefighting measures

### Extinguishing media

**Suitable extinguishing media** The product is not flammable. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

**Unsuitable extinguishing media** Do not use water jet as an extinguisher, as this will spread the fire.

### Special hazards arising from the substance or mixture

**Specific hazards** Containers can burst violently or explode when heated, due to excessive pressure build-up.

### Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Avoid breathing fire gases or vapours. Control run-off water by containing and keeping it out of sewers and watercourses. If risk of water pollution occurs, notify appropriate authorities.

**Special protective equipment for firefighters** Wear positive-pressure self-contained breathing apparatus (SCBA) and appropriate protective clothing. Firefighter's clothing conforming to Australia/New Zealand Standards AS/NZS 4967 (for clothing) AS/NZS 1801 (for helmets), AS/NZS 4821 (for protective boots), AS/NZS 1801 (for protective gloves) will provide a basic level of protection for chemical incidents.

**Personal precautions** Keep unnecessary and unprotected personnel away from the spillage. No action shall be taken without appropriate training or involving any personal risk. Wear protective clothing as described in Section 8 of this safety data sheet. Follow precautions for safe handling described in this safety data sheet. Wash thoroughly after dealing with a spillage. Ensure procedures and training for emergency decontamination and disposal are in place. Do not touch or walk into spilled material.

### Environmental precautions

**Environmental precautions** Avoid discharge into drains or watercourses or onto the ground. Contain spillage with sand, earth or other suitable non-combustible material.

### Methods and material for containment and cleaning up

**Methods for cleaning up** Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Neutralise with acid. Absorb in vermiculite, dry sand or earth and place into containers. Containers with collected spillage must be properly labelled with correct contents and hazard symbol. Flush contaminated area with plenty of water. Wash thoroughly after dealing with a spillage. Do not empty into drains.

### Precautions for safe handling

**Usage precautions** Read and follow manufacturer's recommendations. Avoid inhalation of vapours/spray and contact with skin and eyes. Good personal hygiene procedures should be implemented. Observe any occupational exposure limits for the product or ingredients. Keep away from food, drink and animal feeding stuffs. Handle all packages and containers carefully to minimise spills. #### Appropriate engineering controls

Provide adequate ventilation. All handling should only take place in well-ventilated areas. Avoid inhalation of vapours and spray/mists.

#### Eye/face protection

Eyewear complying with an approved standard should be worn if a risk assessment indicates eye contact is possible. Unless the assessment indicates a higher degree of protection is required, the following protection should be worn: Tight-fitting safety glasses. Personal protective equipment for eye and face protection should comply with Australia/New Zealand Standard AS/NZS 1337.

#### Hand protection

Chemical-resistant, impervious gloves complying with an approved standard should be worn if a risk assessment indicates skin contact is possible. The most suitable glove should be chosen in consultation with the glove supplier/manufacturer, who can provide information about the breakthrough time of the glove material. To protect hands from chemicals, gloves should comply with Australia/New Zealand Standard AS/NZS 2161.
